Nature of Contract:

This contract specifies the commitment between Dynamic Sound & Lighting and the undersigned client pertaining to services to be provided by Dynamic Sound & Lighting and the fees and other responsibilities to be provided by CAMBELL COUNTY HIGH SCHOOL Lisaan Cooper & Cindy Nicolai (From this point on to be referred to as Client).

Our Responsibilities:

Dynamic Sound & Lighting agrees to provide recorded Musical Entertainment, Dance Lighting, announcement and other related services at the location and time designated by the Client.

Client Responsibilities:

Client agrees to insure that proper facilities will be provided in regard to the securing of a location, sufficient electrical power is available (6 - 20 Amp Circuits) within 10 feet of stage area, that suitable space is provided for TRUSS (20'D x 32'W) & DJ Booth (8'D x 12'W), that sufficient time is allowed for the setup of equipment (at least 8 hours) and that the Client designate a contact person to communicate with Dynamic Sound & Lighting regarding arrangements and other planning matters.

Services and Fees:

Services are to be provided on MAY 5th 2018 beginning approximately 6pm - MIDNIGHT at GILLETTE COLLEGE PIONEER CENTER. Dynamic Sound & Lighting and the Client agree to the following fees:

For providing DJ Music:	\$ <u>800⁰⁰</u>	(4 hr. minimum charge)
Lighting (Truss)	\$ <u>1500⁰⁰</u>	(one time charge)
Each Additional hour: <u>(2)</u>	\$ <u>150⁰⁰ = 300⁰⁰</u>	(per hour)
Travel Fee :	\$ <u>400⁰⁰</u>	<u>TOTALING \$ 3000⁰⁰</u>

Client also agrees to make a non-refundable deposit in the amount of \$ 500⁰⁰. This deposit is a part of the total fees as specified above. The absence of said deposit without the approval of Dynamic Sound & Lighting voids this contract. Final payment is due and payable the day of the function. **All checks shall be made payable to: Dynamic Sound and Lighting.**
