- 2 Additional program requested of SPEAKER, outside the terms of this Program Agreement, is subject to additional fee consideration per hour -- as stated by SPEAKER at the time of SPONSOR'S request.
- 3 Audio-video requirements include a quality sound system, hand-held or lavalieri microphone (cordless or 50 feet of cord), full house lights, and if needed for good visibility of the SPEAKER, a raised platform stage. If a gymnasium is being used, please seat audience on one side of the bleachers with the overflow seated on floor level.
- 4 If agreement is canceled by SPONSOR and the date is not resold, the following percentage of the fee will be in effect from the time notification is given to Chris Fisher at The Fisher Agency: 3 weeks or less prior to scheduled engagement = 100% plus airline penalties incurred by Speaker, 31 days or more = 50% plus airline penalties. If date is resold, Holding Deposit can be reapplied to future booking, within a year, with the same SPEAKER.
(*** CANCELLATION MUST BE DONE IN WRITING)
- 5 If SPEAKER cancels due to unforeseen personal emergency or airline/weather complications, The Fisher Agency will make its best effort to find a speaker, for this event, of equal value/talent that is acceptable to the the client or immediately refund the Holding Deposit. If another speaker is not located, no further payment by SPONSOR is required.
- 6. If SPEAKER has commenced travel to your event, and engagement is canceled due to an Act of Mother Nature (example - ice storm, earthquake) or dangerous situation (example - riots, violence), SPONSOR will be responsible for travel expenses incurred by SPEAKER. SPEAKER'S fee will not be charged, the Holding Deposit (if collected) will be applied to travel expenses, and any excess funds from the Holding Deposit will be refunded to SPONSOR.
